The Teamsters, Local 690 (Teamsters) was certified by the Public Employment Relations Commission as the exclusive bargaining representative of certain employees of Washington State University. *Washington State University*, Decision 10136 (PSRA 2008). On April 16, 2015, the Teamsters disclaimed interest in the representation of the bargaining unit.

NOW, THEREFORE, it is

ORDERED

The certification issued by the Public Employment Relations Commission in this case is withdrawn, and the employees are no longer represented by the Teamsters for purposes of collective bargaining.
