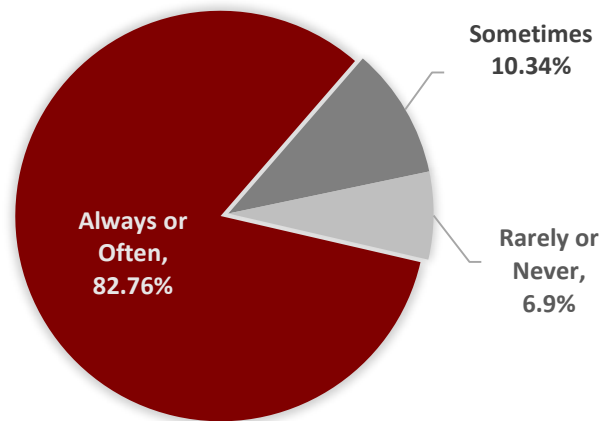


COLLEGE OF PHARMACY

For the 2016 Employee Engagement Survey (EES) there were 32 respondents in 2016 compared to 33 respondents in 2014 who identified their department within the College of Pharmacy. Within the College of Pharmacy, the response average for statements 1-38 was 3.97, resulting in a 2.32% increase in the overall response average from 2014. Of those who responded, 21.88% were administrative professionals, 34.37% were classified staff, and 43.75% were faculty.

As explained in the 2016 EES Results Report, responses were measured using a 5-option Likert scale with “Never” equaling 1 and “Always” equaling 5 to determine the frequency in which employees identified with the statements.

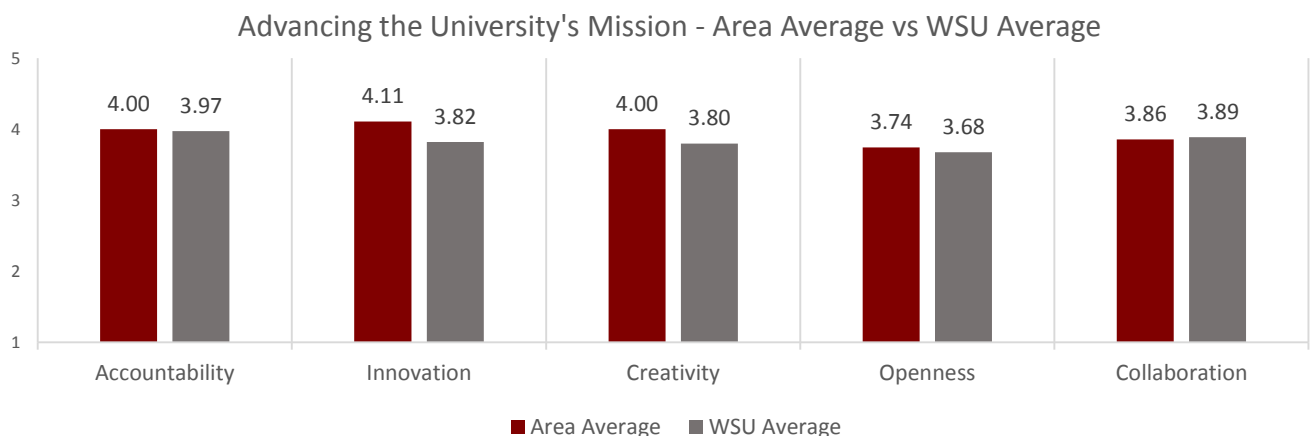
The overall satisfaction at work (statement 38) increased from 4.06 in 2014 to 4.13 for 2016. Additionally, for the 2016 survey, 82.76% of respondents said they always or often enjoy being part of their department (statement 28). ADVANCING THE UNIVERSITY'S MISSION:

For 2016, the survey asked respondents to identify the extent to which their department approached advancement of the University's mission, specifically as it related to the University goals of accountability, innovation, creativity, openness, and collaboration. This graph demonstrates the response average within College of Pharmacy compared to the overall WSU average:

UNIVERSITY RESOURCES:

Based on feedback, the 2016 survey added additional statements regarding workplace concerns and employee awareness of WSU resources, specifically those resources related to Workplace Violence, Bullying, State Ethics, Discrimination, Sexual Harassment and Sexual Misconduct. This graph demonstrates the percentage of employees who identified awareness of the following University policies within College of Pharmacy:

Policy Prohibiting Discrimination, Sexual Harassment, and Sexual Misconduct	93.75%
Washington State University Ethics, Conflict of Interest, and Technology Transfer	81.25%
Workplace Violence	78.13%
Bullying Prevention and Reporting	59.38%

EMPLOYEE FEEDBACK:

At the end of the survey, employees were given the opportunity to provide feedback regarding subjects not addressed in the survey. The following feedback, specifically related to employee perceptions of the workplace, was provided by respondents who identified themselves within College of Pharmacy:

ACTION ITEMS:

In reviewing the lowest area response averages and the statements with negative change from 2014 to 2016 in College of Pharmacy, initiatives to improve employee engagement and perceptions of the workplace may include, but are not limited to:

- Identify positions with inappropriate compensation
- Improve communication efforts regarding changes at the department, college, and university levels
- Encourage communication with employees on how success is measured and provide on-going feedback on how to improve performance
- Evaluate how input is solicited and taken into consideration
- Improve communication regarding the WSU policies concerning workplace violence and bullying prevention and reporting, and provide employees with resources as appropriate
