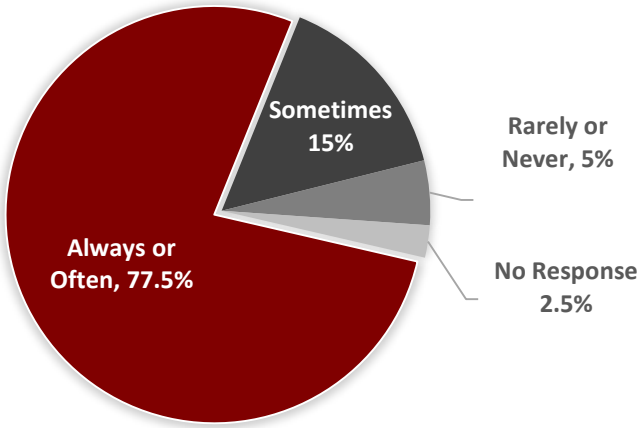


LIBRARIES

For the 2016 Employee Engagement Survey (EES) there were 40 respondents in 2016 compared to 42 respondents in 2014 who identified their department within Libraries. Within Libraries, the response average for statements 1-38 was 4.04, resulting in an 8.9% increase in the overall response average from 2014. Of those who responded, 10% were administrative professionals, 52.5% were civil service and 37.5% were faculty.

As explained in the 2016 EES Results Report, responses were measured using a 5-option Likert scale with “Never” equaling 1 and “Always” equaling 5 to determine the frequency in which employees identified with the statements.

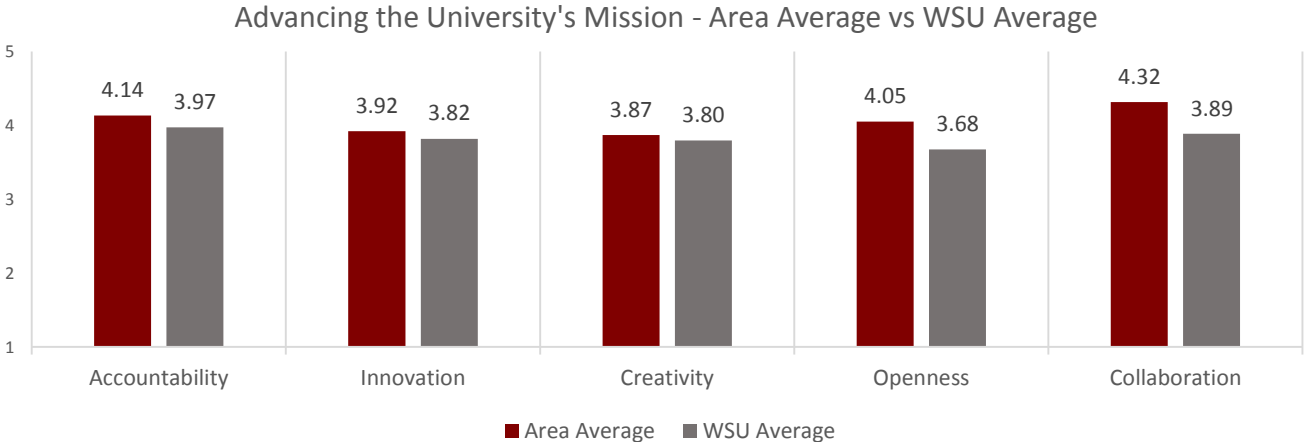
The overall satisfaction at work (statement 38) increased from 3.81 in 2014 to 3.98 for 2016. Additionally, for the 2016 survey, 77.5% of respondents said they always or often enjoy being part of their department (statement 28). ENJOY BEING PART OF THEIR DEPARTMENT

ADVANCING THE UNIVERSITY’S MISSION:

For 2016, the survey asked respondents to identify the extent to which their department approached advancement of the University’s mission, specifically as it related to the University goals of accountability, innovation, creativity, openness, and collaboration. This graph demonstrates the response average within Libraries compared to the overall WSU average:

UNIVERSITY RESOURCES:

Based on feedback, the 2016 survey added additional statements regarding workplace concerns and employee awareness of WSU resources, specifically those resources related to Workplace Violence, Bullying, State Ethics, Discrimination, Sexual Harassment and Sexual Misconduct. This graph demonstrates the percentage of employees who identified awareness of the following University policies within Libraries:

Policy Prohibiting Discrimination, Sexual Harassment, and Sexual Misconduct	97.5%
Washington State University Ethics, Conflict of Interest, and Technology Transfer	90%
Bullying Prevention and Reporting	77.5%
Workplace Violence	75%

EMPLOYEE FEEDBACK:

At the end of the survey, employees were given the opportunity to provide feedback regarding subjects not addressed in the survey. The following feedback, specifically related to employee perceptions of the workplace, was provided by respondents who identified themselves within Libraries:

- Employee input is not taken into consideration
- Secrecy, and lack of communication (campus community input/and involvement) during the presidential search was upsetting
- Lack of planning and forethought when making key decisions (initiatives or mandates) is disappointing

ACTION ITEMS:

In reviewing the lowest area response averages within Libraries, initiatives to improve employee engagement and perceptions of the workplace may include, but are not limited to:

- Improve communication regarding the WSU policy concerning workplace violence and provide employees with resources as appropriate
- Provide employees with resources for workplace climate concerns and encourage the reporting of concerns
- Improve communication efforts regarding changes at the college or area level and at the university level
