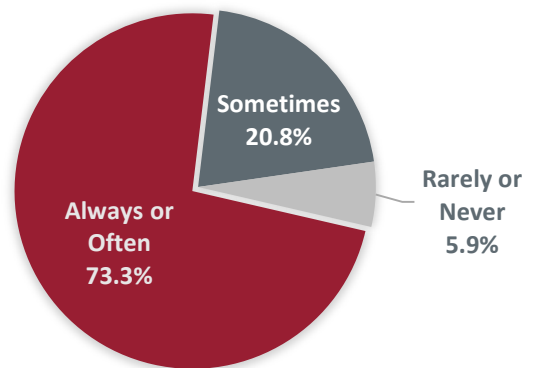


For the 2018 Employee Engagement Survey (EES) there were 66 respondents in 2018 compared to 30 respondents in 2016 who identified their department within Academic Outreach & Innovation. For 2018, the survey was sent to 98 active employees within Academic Outreach & Innovation resulting in a 67% response rate. The response average for statements 1-39 was 3.91 for 2018 compared to 3.72 in 2016 resulting in an increase in the overall response average from 2016. For 2018 56.1% identified themselves as Civil Service and 43.9% identified themselves as Administrative Professional.

As explained in the 2018 EES Results Report, responses were measured using a 5-option Likert scale with “Never” equaling 1 and “Always” equaling 5 to determine the frequency in which employees identified with the statements.

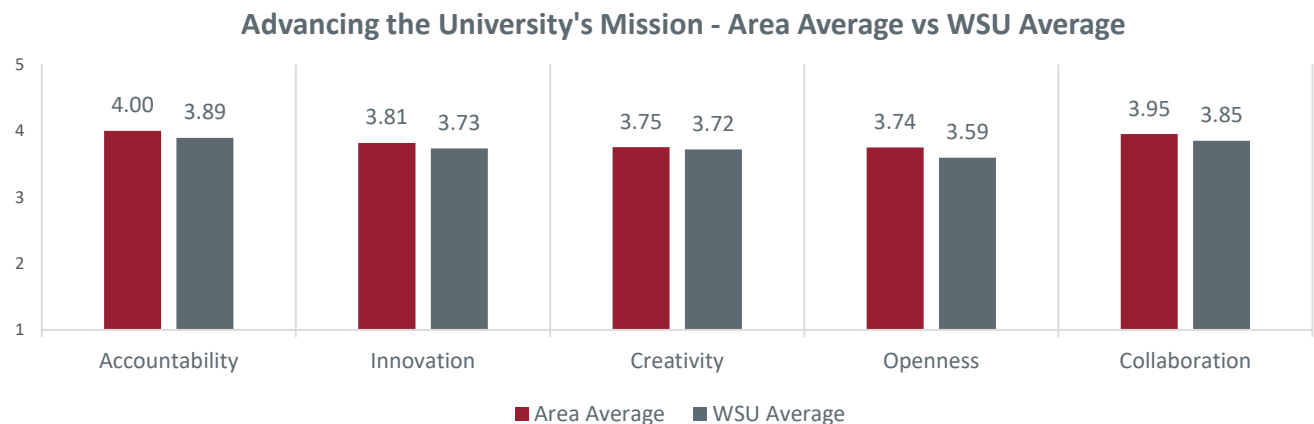
For the 2018 survey, 75.8% of respondents said they always or often enjoy being part of their department (statement 28). Additionally, the response average for overall satisfaction at work (statement 39), increased to 3.95 from 3.83 for 2016. ADVANCING THE UNIVERSITY’S MISSION:

The survey asked respondents to identify the extent to which their department approached advancement of the University’s mission, specifically as it related to the University goals of accountability, innovation, creativity, openness, and collaboration. This graph demonstrates the response average within Academic Outreach & Innovation compared to the overall WSU average:

ACTION ITEMS:

In reviewing the lowest area response averages and the statements with negative change from 2016 to 2018 in Academic Outreach & Innovation, initiatives to improve employee engagement and perceptions of the workplace may include, but are not limited to:

- Provide employees with resources regarding employee wellness and encourage the use of WSU employee wellness programs.
- Ensure supervisors are familiar with resources and provide employees with resources as appropriate and encourage the use of University resources.
- Identify positions with inappropriate compensation.
- Improve communication efforts regarding changes at the department level.
- Evaluate how input is solicited and taken into consideration.
- Identify ways to encourage innovation and creativity in the workplace.

ACTION ITEMS (CONTINUED):

- *Evaluate employee training efforts and encourage training and learning opportunities on the job.*
- *Provide employees with internal and external resources for workplace climate concerns and encourage the reporting of concerns.*

EMPLOYEE FEEDBACK:

At the end of the survey, employees were given the opportunity to provide feedback regarding subjects not addressed in the survey. The following feedback, specifically related to employee perceptions of the workplace, is a synopsis of comments provided by respondents who identified themselves within Academic Outreach & Innovation:

- *Administrators give themselves additional pay every year and never take care of anyone but themselves.*
- *Collaboration with other work sites is discouraged by admin, but within our work site it's the norm.*
- *Employees should be provided the opportunity to review their supervisor.*
- *There is lots of harassment and bullying going on in AMS and nothing is being done; There needs to be an outside resource for issues concerning bullying/whistleblowing and other ethics problems.*
- *Put more of an emphasis on learning and communicate the importance of active learning and defining student expectations and instructor expectations.*
- *Many are at a point of not trusting our supervisor and are afraid the the backlash that would come if we were to bring it up.*
