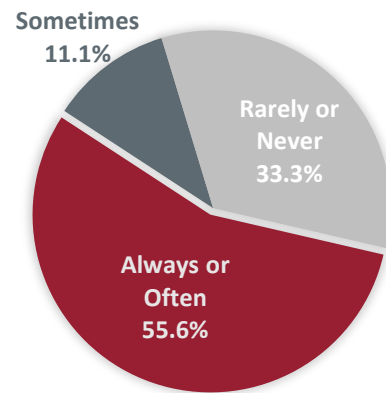


For the 2018 Employee Engagement Survey (EES) there were 7 respondents in 2018 compared to 9 respondents in 2016 who identified their department within Governmental Relations and External Affairs. For 2018, the survey was sent to 7 active employees within Governmental Relations and External Affairs resulting in a 100% response rate. The response average for statements 1-39 was 3.38 for 2018 compared to 4.10 in 2016 resulting in a decrease in the overall response average from 2016. For 2018, 88.9% identified as Administrative Professional and 11.1% identified themselves as Civil Service.

As explained in the 2018 EES Results Report, responses were measured using a 5-option Likert scale with “Never” equaling 1 and “Always” equaling 5 to determine the frequency in which employees identified with the statements.

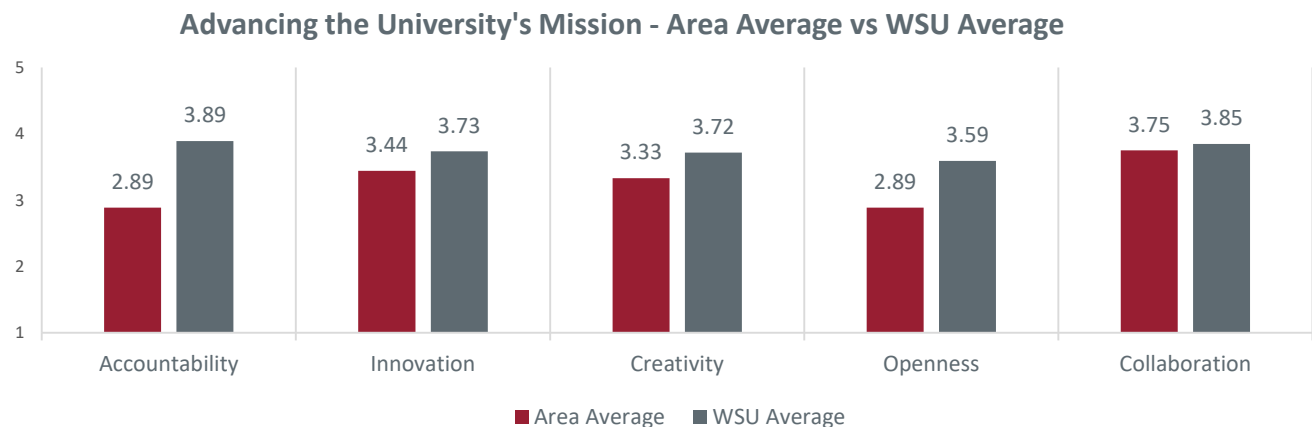
For the 2018 survey, 55.6% of respondents said they always or often enjoy being part of their department (statement 28). Additionally, the response average for overall satisfaction at work (statement 39), decreased to 3.63 from 4.14 for 2016. ## ADVANCING THE UNIVERSITY'S MISSION:

The survey asked respondents to identify the extent to which their department approached advancement of the University's mission, specifically as it related to the University goals of accountability, innovation, creativity, openness, and collaboration. ## ACTION ITEMS:

In reviewing the lowest area response averages and the statements with negative change from 2016 to 2018 in Governmental Relations and External Affairs, initiatives to improve employee engagement and perceptions of the workplace may include, but are not limited to:

- *Provide employees with resources regarding employee wellness and encourage the use of WSU employee wellness programs.*
- *Ensure supervisors are familiar with resources and provide employees with resources as appropriate and encourage the use of University resources.*
- *Provide employees with on-going feedback and recognition.*
- *Evaluate efforts to advance the University's mission as it relates to accountability and openness.*
- *Evaluate how input is solicited and taken into consideration.*
- *Provide employees with internal and external resources for workplace climate concerns and encourage the reporting of concerns.*

## EMPLOYEE FEEDBACK:

At the end of the survey, employees were given the opportunity to provide feedback regarding subjects not addressed in the survey. The following feedback, specifically related to employee perceptions of the workplace, is a synopsis of comments provided by respondents who identified themselves within Governmental Relations and External Affairs:

- *Members of my department are being harassed and bullied. Workplace safety at my location is a huge issue and is not taken seriously. WSU is a good employer and I wish employee concerns were addressed instead of passed off.*
- *The loss of several key individuals over the last two years is not only sad, it is a concern.*
- *I value what I do. Program managers are poor leaders focused on controlling behavior rather than promoting innovation and engaged staff.*
