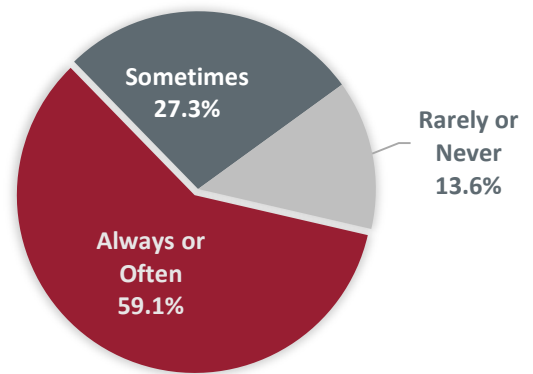


For the 2018 Employee Engagement Survey (EES) there were 44 respondents in 2018 compared to 19 respondents in 2016 who identified their department within International Programs. For 2018, the survey was sent to 70 active employees within International Programs resulting in a 62.9% response rate. The response average for statements 1-39 was 3.74 for 2018 compared to 3.79 in 2016 resulting in a decrease in the overall response average from 2016. For 2018 45.5% identified themselves as Faculty, 38.6% identified as Administrative Professional and 15.9% identified themselves as Civil Service.

As explained in the 2018 EES Results Report, responses were measured using a 5-option Likert scale with “Never” equaling 1 and “Always” equaling 5 to determine the frequency in which employees identified with the statements.

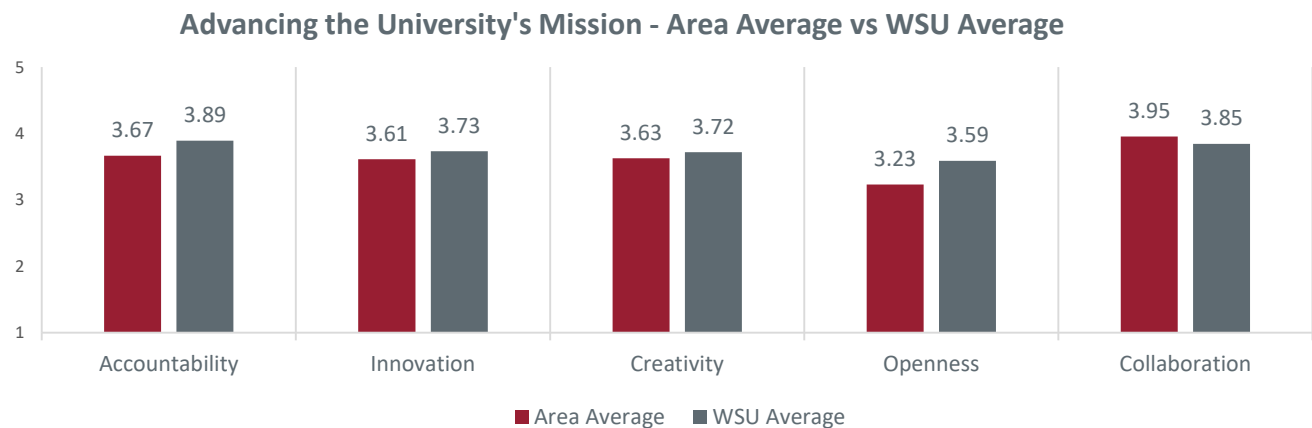
For the 2018 survey, 59.1% of respondents said they always or often enjoy being part of their department (statement 28). Additionally, the response average for overall satisfaction at work (statement 39), decreased to 3.56 from 3.74 for 2016. ADVANCING THE UNIVERSITY’S MISSION:

The survey asked respondents to identify the extent to which their department approached advancement of the University’s mission, specifically as it related to the University goals of accountability, innovation, creativity, openness, and collaboration. This graph demonstrates the response average within International Programs compared to the overall WSU average:

ACTION ITEMS:

In reviewing the lowest area response averages and the statements with negative change from 2016 to 2018 in International Programs, initiatives to improve employee engagement and perceptions of the workplace may include, but are not limited to:

- *Provide employees with resources regarding employee wellness and encourage the use of WSU employee wellness programs.*
- *Ensure supervisors are familiar with resources and provide employees with resources as appropriate and encourage the use of University resources.*
- *Identify positions with inappropriate compensation.*
- *Provide employees with internal and external resources for workplace climate concerns and encourage the reporting of concerns.*
- *Encourage communication with employees on how success is measured and provide on-going feedback on how to improve performance.*

EMPLOYEE FEEDBACK:

At the end of the survey, employees were given the opportunity to provide feedback regarding subjects not addressed in the survey. The following feedback, specifically related to employee perceptions of the workplace, is a synopsis of comments provided by respondents who identified themselves within International Programs:

- *I am fortunate to work with a stellar team.*
- *Overall great place to work.*
- *Incoming employees make too little initially, and employees that have been on campus for a long time often make MUCH higher salaries for doing much less work.*
- *I do not receive benefits from the university, since I work a series of part-time contracts. In addition, I do not have access to reliable substitute teachers, or the ability to cancel class if I am sick. This results in an atmosphere that is not conducive to health and wellness and, in fact, encourages faculty members to come to work sick.*
- *WSU has a formidable task in front of it as an institution with the Drive to 25.*
- *I feel discriminated and not respected by my direct supervisor.*
- *No transparency in my workplace.*
