

NOTICE OF ELECTION BY CARD CHECK

PURPOSE OF CARD CHECK:

Do the eligible employees want to be represented by SCREEN ACTORS GUILD - AMERICAN FEDERATION OF TELEVISION AND RADIO ARTISTS for collective bargaining purposes? The bargaining unit is described as follows:

All full-time and regular part-time professional employees exempt from chapter 41.06 RCW employed by Washington State University – Northwest Public Broadcasting performing content creation in the following job functions: editor, producer, videographer, graphic designer, web designer, social media creator, host, journalist, reporter. Excluding confidential employees, supervisors, employees covered by chapter 41.76 RCW, employees covered by chapter 41.80 RCW, employees performing engineer, maintenance, technician and information technology functions, and employees included in any other bargaining unit.

The list of WASHINGTON STATE UNIVERSITY employees eligible to vote is attached.

ELECTION BY CARD CHECK:

In a card check, PERC will compare the authorization (interest) cards submitted by the union to the list of eligible employees. An authorization (interest) card is a yes vote. The list of eligible employees is attached.

If you would like to revoke your authorization (interest) card for the purpose of a card check, you must submit a signed written request to PERC by **U.S. mail** to PO Box 40919, Olympia, WA 98504 or **email** to filing@perc.wa.gov on or before Monday, September 22, 2025. The card check will occur after the revocation period ends.
